Data on early Kools from Rev. David Cole's book titled "Isaac Kool (Cool or Cole) and Catherine Serven" manual Oct. 15, 1764, at Tappan, Rockland (then part of Orange) County N.Y., John F. Trow & Sons, Printers, 1876.

P. 2 - The name "Kool" first appears on actual record (now extant) in America in 1630 and 1633. On the 13th of August, 1630, Lenart (English spelling "Leonard" and Holland spelling "Leendert" or "Lenart") Kool or Cole signed as Governor Minuit's Deputy Secretary, the famous patent to Killiaen Van Rensselaer for a tract of land upon the Hudson River (See Vol. I - Holland Documents - of "Documents relating to The Colonial History of New York" p. 44). Also, in 1633, Barent Jacobsen Kool and six others, all holding office in the service of The West India Company, signed a document called "Condition and agreement entered into between Commissary Jacob Van Curler and the Chiefs of Sickenanes, on the 8th of June, 1633, (See Vol. II of the same "Documents" page 140)".

Page 22 --- "The first appearance of Barent Jacobsen Kool on any American civil record, as we have seen, bears the date of June 8, 1633. The record shows that at that time he held an office in the service of the West India Company. He had probably then been a resident of New Amsterdam for some time. It is likely, as already said, that he came over with Peter Minuit in 1626. But, beginning with 1633, we can trace him through civil records, and beginning with 1640, we can trace him through Church and civil records, down to 1665, the year after the surrender of New Amsterdam to the English. The directory of the city for 1665 is extant. Valentine (David T.) gives it (from page 356 onward) in his "Manual of the New York Common Council" for 1649, and also in his "History of New York" (pages 121-124). In his "History of New York", (pages 71-100) he speaks of our first American ancestor. He says: "Barent Jacobsen Kool was in this city as early as the year 1633, and held office in the service of The West India Company. "His name appears upon the list of those who took The Oath of Allegiance to the new English Government, October 21, 22, 23 and 24, 1664 (see Vol. III "Documents relating to the Colonial History of the State of New York", pages 74-76). It is alphabetically placed among the Js, being entered thus: "Jacobsen Kool, Barent". After this, I cannot find him again in any New York City record. From 1660 to 1690 most of his children appear on the Church records at Kingston. Taking into consideration that already, in 1633, he was prominent in public office, it seems to me that he could not have been born later than 1605, and that his father, Jacob Kool, our last ancestor in Holland was born, not far at the latest, from 1580. Possibly and probably his birth occurred earlier than this. He was a respected and influential Holland Burgher of the early American period. Under the "Act of the Burgomasters of New Amsterdam" passed May 5, 1654, he was appointed as one of two Excisemen whose official duty it was to guard the wine and beer trades against fraud, (Valentine's Manual for 1845-46, pages 358-361). For his family, we are indebted to Church records of the Reformed Church of N.Y. now Collegiate). (Rev. Cole thinks that Mr. and Mrs. Kool were married in this country.) He had nine children, all born in this country. Page 25 gives Leendert's line, marriage and children. (Foot note, either named for his Mother's Family, or for Parent Jacobsen's brother, Leendert)

Children of Barent Jacobsen Kool from pages 24-25:

* It is a custom of the Dutch to use the name of a child who dies, for another child, born later.

On page 26 of the Book of Deeds AA in County Clerk's office at Kingston, also on pages 70 and 266 of the same volume, and again on page 404, Book BB, are found deeds of land sold by Leendert Kool to different individuals. The first of these deeds is dated February 18, 1685, and the last, 1700. In these, he styles himself Leendert Kool and calls his wife "Mary". The deeds show that his residence was at Marbletown in Ulster County, about seven miles from Kingston, but he attended Church at Kingston.

"I may add here that possibly Leendert Cool and Marretje Della, who were stated a few pages back to have had a son Cornelis, Bapt. in New York April 18, 1694, may have been Leendert Cool and Marretje Cornelis. If so, the wife's full name was Marretje Cornelis Della. Della appears, however, nowhere else in the many occurrences of her name."

To a Hollander, the name "Barent Jacobsen Kool" told this story - it means Barent (same as Barnard or Benardus) Kool, son of Jacob Kool and shows by its mere form that Jacob Kool was the last ancestor in Holland. ("se" is equivalent to "son of").

The name Kool did not become firmly fixed as a family name for all until about 1690. Some families not using Kool, floated off as Jacobseus, Barentseus, Barnards, Bernharts, even Barent Jacobsen Kool omitted "Kool" on some Baptismal records of his children. The letter "C" is not known to the pure Holland language. Put in America, the "K" almost immediately changes to "C". Thus, Jakobus became Jacobus, Klaas became Claas, Kool became Cool, etc. Not all Coles are Holland Dutch. Many in the eastern U.S. came from England, Cole, Coles, Cowle, Cowles, Coal, Coale and Coales. Kool was pronounced as we pronounce the word Cole today. Our Kools, or Coles, are the only ones direct from Holland, others from England and Germany are not ours.

The line of Theunis (?) Kool, 8-17-1653, is in the "Biography of Cornelius Cole", famous Senator of California in the 1800s. This book has a most interesting story of New York as the Dutch founded it, and the way they lived at that (1630) time.

I have the following book which has beautiful illustrations and grand text of New Amsterdam, one picture similar to a De Rapalje cradle, of which I have a black and white photostat. On page 20, Catalyntje Rapalje is named as an immigrant, also her father and mother, with quotes of what she said about her trip and arrival. Plate 118 shows an illustration of a gold clasp she wore around her neck on a ribbon. On the reverse side is the maker's mark and "CR". This clasp went through the family from Calantje's son David to Annie Marie, wife of Charles Underhill of Fishkill N.Y., who was its owner in 1940. The name of this book is "Album of New Netherland" by Maud Esther Dilliard, New York City, Twayne Publishers Inc., 1963. The book was printed in Japan. You may get a copy at a second-hand store, or get your book store to get one for you, cheaper at remainder store (2nd hand).. I paid around fifteen dollars for it, though can't remember for sure. A beautiful book.

Jean (John) Crocheron, Father of Margaret, had the first mill on Staten Island. It is now being reconstructed at Richmond on the island, where this town will be an exhibit place to show early Huguenot living.

The following pages contain a brief outline of the lives of the various members of this Family Record. Unfortunately, in many instances names only are known. Much more has been recorded concerning certain lines, particularly regarding other members of their families, "their sisters and their cousins and their aunts", too much to be included in this abridged record. Need is indicated for further research on the Perrine, Puxton, Davis, Patton, Burns, McClintock, Fisher and Askren lines. We are indebted to Miss Nancy Lee Carmichael (see Gen. A) for much of the data on the Cole (Kool) and Van Nest lines. Much of the data on the Beall (pronounced "Bell") lines was supplied by Gerald Carr Smith, husband of Leah Beall, granddaughter of Edmund Beall D-7. Miss Carmichael insisted on documentary proof of all data supplied by her. This may not be strictly true of other lines.

M 3135 William Harris came to Maryland (some records say Virginia) in 1647, from England.

M 3137 Nathaniel Bacon, England to Virginia, date not known.

M 3481-3482 John and Winifred Gilbert, England to Massachusetts in 1630.

L 1 Jacob Kool, Lived in Amsterdam Holland. Did not come to America.

L 19-20 Jan Janse and Engltje Von Breastede, ?

L 33-34 Roeloff and Catryn Swartwout, were residents of Gronigen, Holland.

L 35 Barent Osten, was a book publisher in Amsterdam, Holland.

L 39-40 Barent & Geesie Van Rolmers. ?

L 69 Jean De Rapalie, A resident of France.

L 71 Joris Trico, Lived in Vincennes France and was a Huguenot.

L 1555 William Braithwaite, England to Maryland in 1635.

L 1559-1560 Richard and Jane Moore, to Maryland 16??, probably from England.

L 1567-1568 James & Elizabeth Harris Warner, England to Maryland in 1645.

L 1583-1584 John & Elizabeth Bacon Nuthall, John came from England to Virginia (one record says Maryland). They were married in America.

L 1741-1742 Thomas Sr. & Jane Rossiter Gilbert. ?

L 1743-1744 William Sr. & Hannah Blake, William from England to Massachusetts in 1630. They were probably married in America.

K 1-2 Barent Jacobsen & Marretje Leenderts Kool, Barent J. came from Holland to New Amsterdam (now N.Y. City) c1625. Was an officer of The West Indies Company in 1633. Probably came with Peter Minuit. Married in America. Had 9 children, Leendert, J-1 was 5th.

K 9-10 Hendrik J. & Elsie Breesetede Schoonmaker: Hendrik was born in Hamburg, Germany, came to America in the military service of Holland. Settled at Albany in 1655 and was in Kingston in 1659. Married Elsie Breesetede, had six children, J-5 was the second. Elsie was the widow of Adriaen Van Alainaer, by whom she had three children.

K 11 Samuel Berry ?

K 17-18 Tomys & Hendriks Parents Swartwout: In 1653 Tomys was a member of a Convention to "Represent to the Authorities in Holland, the state of the Country", and signed a petition representing Brueckelen (Brooklyn). In 1655 he was a magistrate of Midout (Flatbush).

K 19-20 Albert & Annetje Van Rolmers Bradt: Albert was often called "Albert the Norman". He was a tobacco planter and one of the first inhabitants of the Colony of Rensselaerwyck. The Bradt family originated in Norway and had a Coat of Arms.

K 35-36 Joris Jansen & Catherine Trico De Rapallie: Joris was born in Holland. He was a French Huguenot of Noble French descent. Came to Fort Orange in 1623, moved to New Amsterdam in 1626. Was a Magistrate in Brooklyn. Married in America. Catherine, daughter of Joris Trico of Valencennes France, was also a Huguenot.

K 51 Andreas De Vos: Was a Deputy Director of Rensselaerwyck and a French Huguenot.

K 59 Captain Le Fevre: A Huguenot. Fled from France, came to Newton L.I. in 1660, later moved to Utrecht L.I.

K 777-778 Alexander & Margaret Braithwaite Magruder: Alexander came to Maryland from Scotland in 1652. His wife was probably with him.

779-780 Ninian & Ruth Moore Beall: Ninian came to Maryland from Scotland in 1652.

K 781-782 John Sr. & Elizabeth Howard Brewer: This family came from Wales to Massachusetts (one record says Maryland) in 1645, when their son John Jr. was 1 year old.

K 783-784 Henry & Sarah Warner Ridgeley: Henry came to Maryland from England with his parents in 1659, when he was 14 years old.

K 791-792 Thomas & Fleanor Nuthall Sprigg: Thomas came from England to Maryland in 1650. Probably married after coming to America.

K 865-866 Solomon & Mary Leonard: Solomon came to Massachusetts from England in 1630. Evidently married after coming to America.

K 871-872 Thomas Jr. & Ann Blake Cilbert:

J 1-2 Leendert & Marretje Cornelis Kool: This family lived at Marbletown in Ulster County N.Y. Attended Church in Kingston. Had six Children, two of which died in infancy.

J 3-4 Andreas & Marietje Davis Van Leuven: This family lived in the Minisink Valley in the vicinity of Kingston N.Y. Were members of the Kingston Reformed Church.

J 5-6 Egbert J. & Annetje Berry Schoonmaker: ?

- J 9-10 Roeloff & Eva Bratt Swartwout: Roeloff lived in Gronigen Holland, came to New Amsterdam c1650, married Eva Bratt, widow of Antoine De Hooges, in 1657 in Beavertuyck. Eva was of Norwegian descent but was probably born in Holland.
- J 11 Jacobus Coobes ?
- J 17-18 Pieter P. Sr. & Judith De Rapalie Van Nest: Pieter came from Holland to Brooklyn in 1647. Was on the assessment rolls of Brooklyn 1675-76 & 83. Took oath of allegiance in 1687. Judith was baptized July 6, 1635.
- J 19 John Crocheron: A Huguenot. Lived on Stater Island, had the first mill on the island. The mill is now (1972) being reconstructed at Richmond S.I. as a show place of early Huguenot living.
- J 25-26 Christoffel & Cornelia De Vos Davids: Christoffel born in England, was at the Massachusetts Bay Colony in 1636, died in Ulster County N.Y. He was an Indian interpreter and was called "Captain Kit".
- J 27-28 Frederick & Engeltje Hendricks Mauritz: Came from Holland, lived in Kingston N.Y.
- J 29-30 Bourgon & Catherine Le Fevre Brokaw: Bourgon was born in France, was a Walloon and a Huguenot, was a member of that Church in Mannheim, German Palatinate. Moved to Amsterdam Holland c1672, and to New York City in 1676. Catherine was born in France. She was Bourgon's second wife, the first being Marie Du May.

- J 389-390 Samuel & Sarah Reall Magruder ?
- J 391-392 John Jr. & Sarah Ridgeley Brewer ?

- J 403 Edward Brock: To Maryland from England.
- J 433-434 Isaac & Deliverance Brown Leonard: ?
- J 435-436 William & Hannah Cilbert Phillips: William came to Massachusetts from England in 1677.
- J 451-452 John & Sarah Carey Jenny ?
- J 453-454 Dr. Samuel & Bridget Lee Fuller: Dr. Samuel came from England to Massachusetts in 1620, on the Mayflower. His wife is believed to have been with him.
- I 1-2 Harmanus & Cornelia Van Leuven Kool: Harmanus was Baptized April 24, 1681 in Kingston N.Y. Cornelia was Baptized in the Dutch Church in Kingston in October 1685. Marriage Banns April 5th, 1707 in Kingston. Lived in the Minisink Valley.
- I 3-4 Samuel & Eleanor Feny Schoonmaker: Samuel was in Kingston N.Y. at the time of his death.
- I 5-6 Antoni & Jannetje Coobes Swartwout: Antoni was born in Kingston N.Y. After Antoni's death, Jannetje married Heromandus Barentsen of Nimweran, Holland.
- I 7-8 Jacob & Jannetje Hendricks Decker: Both were residing in Mombackus (a large area including what is now Rochester N.Y.) at the time of their marriage.

- I 9-10 Pieter Pieterse Jr. & Margaret Crocheron Van Nest: Pieter was born in New Amsterdam and resided at the Wallabout. Was a member of the Dutch Reformed Church in 1677. Later settled on the Raritan near Sommerville and was a member of the Assembly of East New Jersey in 1699. Margaret was Pieter's second wife, the first having been Trantje Jans.
- I 13-14 Isaac & Jannetje Mauritz Davids: Isaac was Baptized c 1668 at Marbletown, Ulster County N.Y. Died at the same place. Was an Indian Interpreter, as was his father. Jannetje lived in Kingston before marriage.
- I 15-16 Peter & Judith Van Nest Brokaw: Peter was born on Long Island, became a farmer. Had two farms on the Raritan in N.J. Judith was Baptized September 30, 1685, in the N.Y. Dutch Church.
- I 193-194 Alexander Jr. & Elizabeth Coombs Beall: Alexander came to Maryland from Scotland in 1666. Elizabeth probably born in America.

- I 227-228 Rev. Samuel & Elizabeth Fuller: ?
- H 1-2 Andreas & Sara Schoonmaker Cool: Andreas was born in Deer Park Long Island. Was Baptized Nov. 4th, 1716. His will was dated 11-5-1795. Sara Baptized 1-15-1719.
- H 3-4 Bernardus & Gretje Decker Swartwood: Bernardus was Bapt. in Kingston N.Y. on Oct. 31, 1697. Gretje Bapt. 3-31-1700 in Ulster County N.Y.
- H 5-6 Jeronimus & Susanna Van Nest: This family lived on Long Island. Had seven children listed in their Family Bible.
- H 7-8 George & Judith Brokaw Davis (Davids): George was born in Kingston. Became a farmer on the Raritan in N.J. Judith was born in Somerset County N.J.
- H 97-98 William & Sara Magruder Beall: ?
- H 99-100 Nathaniel & Ann Murdock Beall: ?
- H 101-102 William Jr. & Jane Joyce Offutt: ?
- H 109-110 Caleb & Jenima Minthorn Leonard: Caleb was born in Mendham N.J.
- H 111-112 Joseph & Mary Burt: ?
- H 113-114 James & Experience Fuller Wood: ?

- G 1-2 Harmanus & Margaret Swartwood Cole: Margaret was born in Deer Park L.I. and Harmanus probably at the same place, since his father, Androus Cool, was born there. They were married in Maghaghkemeck N.Y. They later owned 1800 acres of land in Washington County Pa. Just when, how, or why they came to Pa. is not known. They are believed to be buried in the Cross Creek Pa. cemetary. They had eight children, Moses F-1 having been the oldest.
- G 3-4 Pieter & Catherine Davis Van Nest: Catherine was Baptized 1-18-1735 in Somerset N.J. Pieter Bapt. 1737, Probably on Long Island.
- G 25-26 Henry & Agnes Carson Maxwell: Married in Ireland but believed to be of Scotch descent. Came to Pa. c1770 and later moved to Brooke County Va. (now W. Va.). Had seven children, Thomas F-13 being the oldest. Henry served as a private in The Revolutionary War.
- G 29-30 Andrew & Martha Watson Orr: Believed to have lived in County Downs, Ireland. Did not come to America.
- G 31-32 ? and Martha Calhoun Huston: Martha was a member of an English family of high social standing.
- G 49-50 Mordecai & Elizabeth Beall: Mordecai was a soldier in the American Revolution from Maryland.
- G 51-52 Alexander & ? Perry Offutt: Alexander was a soldier in the American Revolution from Maryland.
- G-53-54 Liverton & Mary Buchanan Thomas: Liverton was a soldier in the American Revolution from Pennsylvania.
- J 55-56 Caleb Jr. & Sarah Burt Leonard: Caleb was a soldier in the American Revolution from Pennsylvania.
- G 57-58 Jonathan & Persis Robbins Wood: ?
- F 1-2 Moses & Judah Van Nest Cole: Farmers in Washington County Pa. Buried in the Cross Creek Cemetary. Had eight children, Samuel E-1 being the second.
- F 5-6 Jacob Sr. & Hannah Buxton: Farmers in Washington County Pa. Buried in the Cross Creek Cemetary. Had five children, Jabob Jr. E-3 being the oldest.
- F 13-14 Thomas & Jane Meek Maxwell: Farmers, originally from Brooke County Va. (Now WVa.), later settled near Cadiz, Ohio. Had eleven children, Henry E-7 being the fourth.
- F 15-16 Robert & Ann Huston Orr: Robert born in County Downs, Ireland. Came to America in 1795. Met Ann Huston on the ship and they were married five years later. Moved from Westmoreland County Pa. to Harrison County Ohio c1875. Had nine daughters, no sons. Much more available on this family.
- F 25-26 Colmer & Jane Offutt Beall: Colmer born in Frederick County Md. Joined a migration to western Pa. headed by his wife's uncle, Zephaniah Beall, for whom Beallsville Pa. is named. Colmer had three wives, Jane being the second.
- F 27-28 Edmund & Rhoda Leonard Thomas: ?
- F 29-30 James & Achoah Phinney Wood: This family moved from Bridgewater, Berkshire County Mass., to Washington County Pa. in 1787.

- E 1-2 Samuel & Amy Perrine Cole: Farmers, Washington County Pa. Samuel married twice, Amy being the first. Had 16 children altogether, six first wife, ten second wife. Moses D-1 was oldest of the 16.
- E 3-4 Jacob Jr. & Elizabeth Davis Buxton: Lived in Washington County Pa. Had a combination flour and sawmill on Cross Creek, just over the State line in Brooke County WVa. Jacob married twice, Elizabeth having been second. Had 20 children altogether, Rebecca D-2 being the 15th. Much data available on this family.
- E 5-6 Joseph & Sarah Burns Patton: Natives of Fayette County Pa. Moved to Rumley Twp., Harrison County Ohio in 1817. Had ten children, James D-3 being the 6th.
- E 7-8 Henry & Esther Orr Maxwell: Were living in Crawfordsville Iowa in 1860.
- E 9-10 John & Lavina Henderson: John born in Ireland. This family lived for a time in Westmoreland County Pa. later moved to Harrison County Ohio, on what is now (1973) State Route 151, one mile east of Scio. Lavina was the foster daughter of a family, also by the name of Henderson. Had 10 children, James D-5 being the oldest.
- E 11-12 Thomas & Elizabeth Fisher McClintock: Farmers, living near Tappan Ohio. Buried in a private cemetery on their home farm. Nine children, Susanna D-6 being oldest.
- E 13-14 Alexander & Sarah Thomas Beall: Came from Washington County Pa. to Nottingham Twp., Harrison County Ohio in 1823. Land patente dated 1828. Nine children, Edmund D-7 being the second.
- E 15-16 Benjamin & Martha Askren Wood: Benjamin born in Berkshire County Mass. Moved with his parents to Washington County Pa. in 1787. Later moved to Moorefield Ohio in 1820. Was a farmer and itinerant Baptist Preacher. Married three times, Martha being third. Had 21 children altogether, Albina D-8 being 16th.
- D 1-2 Moses & Rebecca Buxton Cole: Both born in Washington County Pa., moved to Harrison County Ohio in 1843. Purchased 168 acres of land from Emanuel Custer, father of General George, midway between Scio and Jewett on what is now (1973) State Route 151. Eleven children, Samuel C-1 being the 4th.
- D 3-4 James & Mary Jane Maxwell Patton: Farmers in Rumley Twp., Harrison County Ohio. James was killed when a Pa. Railroad train struck his wagon in Scio. He was married twice, Mary Jane being the second. Nine children, Esther C-2 being 4th.
- D 5-6 James & Susan McClintock Henderson: James Born in Westmoreland County Pa., moved with his parents to North Twp. Harrison County Ohio. Was a carpenter by trade. Susan born on father's farm in Monroe Twp. Harrison County Ohio. Both are buried at the Ridge Cemetery. Ten children, Henry C-3 being the 8th.
- D 7-8 Edmund & Albina Wood Beall: This family lived in Moorefield Ohio. Edmund was married twice, Albina being 2nd. Six children, Clara C-4 being the youngest.
- C-1-2 Samuel & Esther Patton Cole: Samuel born in Washington County Pa., moved with his parents to Harrison County Ohio in 1850. After his father's death, Sam and his mother operated the farm, and Sam succeeded to its ownership after his marriage in 1885. Esther born near New Rumly Ohio, graduated from Scio College in 1875. taught rural schools before marriage. Five children, James B-1 being the youngest.
- C 3-4 Henry W. & Clara Beall Henderson: Henry born in the village of Hanover, near Scio Ohio. Clara born in New Philadelphia Ohio. They were farmers, living near the village of Hanover. Nine children, Florence B-2 was 6th.

- G 5-6 Peter Ferrine Sr., an Englishman by birth, was known to be a resident of Somerset County, New Jersey in 1759. His wife's name not known.
- F 3-4 Peter Jr. and Sarah Harris Perrine. Peter born in Somerset County, New Jersey where he enlisted and served throughout the Revolutionary war under various commands. Married Sarah Harris in Fayette County Pa. in 1790, and in 1794 purchased a tract of land containing 300 acres and known as "Buffalo Lick" in Cross Creek Twp., Washington County Pa. where they spent the rest of their lives. Parents of Sarah Harris not known at this time (1976). Peter and Sarah are buried at the Bethel Cemetery.

Innkeeper, New Amsterdam, New Netherland.

Joris Janszen Rapalje, Huguenot, son of Jean, was baptized 28 April at Valenciennes, died in Brooklyn, New Netherland, probably early in 1663; married 21 January 1624 in Amsterdam, Catalina Trico, daughter of Jeronimus. She was born in Pny, Belgium, about 1605 and died 11 September 1689 in Brooklyn.

Joris Janszen Rapalje, as he was known in New Netherland, was the last of six children of Jean Rapareillet and his unnamed wife. He was baptized 28 April 1604, as entered in the register of St. Nicolaes Roman Catholic Church of Valenciennes. Since 1668 Valenciennes has been in the department du Nord of France. Previously it had been Haincut, a province in the part of Spanish Netherlands.

The name of Joris appears as Georges, illegitimate son of Jean on the baptismal record. It was not unusual for Walloon and Huguenot parents to take their children to Roman Catholic priests to be baptized in the absence of Protestant clergy, or to escape persecution. Similarly, it was not uncommon for the priests to refuse to recognize the validity of Protestant marriages, recording the children of such marriages as illegitimate.

Joris, living in Amsterdam in 1623, with his prospective bride Catalina Trico, had been recruited with a number of other families, probably mostly Walloons, to go as colonists for The West India Compy's venture in America. Their acceptance was subject to their being married before the ship's departure. To meet this requirement necessitated the publication of the intent to marry and the actual marriage, a process which then usually required at least three weeks. The banns for Joris and Catalina were published on Saturday, January 11, 1624, and their marriage took place on Sunday January 21st, at the Walloon Church in Amsterdam, a week earlier than normal. The records indicate that probably their parents were textile workers, and that Catalina was probably born in Pny, Belgium, not too far from Valenciennes.

Four days later, on 25 January 1624, the couple sailed on the Endracht (Unity), Adrian Foriszen Tienpont, skipper. Few of their fellow passengers are known by name, though Sebastian Janszen Krol, John Monfort and his wife Jacqueline Moreau, and about a dozen other families with marriageable daughters and sons, with thirty unaccompanied men were aboard. Some were undoubtedly Walloons. The ship arrived in New Netherland in late March or early April, 1624, and after a stay of a few days went up the Hudson to Fort Orange (Albany), New York. These immigrants were the advance party for the colonization planned by the West India Company. Soon after the harvest of 1626, the Company resettled the eight families living in Fort Orange, in Manhattan, which then became the center of operations for New Netherland. This included the household of Rapalje which now included their first daughter. There were but 270 white inhabitants in Manhattan at this time, and sufficient land so that the families brought down river could support themselves and have sufficient left over for the victualling of ships which would put into port for trade. Since Joris could not follow his trade of weaving under the regulations of the West India Company, he found it expedient to support his family in other ways. He is supposed to have opened the first tavern shortly after arriving in Manhattan. He was a tavernkeeper as late as 16 March 1648 when he and eleven other tavernkeepers promised as true men to live up to the newly imposed rules in every way and as best they could. The extensive rules were designed to control "unreasonable and intemperate drinking" at night and on Sundays, and the owners of taverns must have some other legitimate occupation. Joris chose farming at first and went in for cattle breeding. In June 1637, Joris bought from the Indians a plantation at the cove which the Dutch named "Wallabought". Many years later it became the site of the famous Brooklyn Navy Yard.

The patent for the land was confirmed to Joris Rapalje by Governor Kieft on 17 June, 1643. This farm of 335 acres was always known as "Joresy's Plantation" by the Dutch, and as "Georgie's Plantation" by the English. Until Rapalje's farm was well established and showing a good profit, and until he had satisfactory buildings on it, he and his family continued to live on their property on Pearl Street, which extended to Bridge Street, where the tavern flourished, in Manhattan. About 1654 they removed to the Brooklyn farm.

There is evidence that Joris Rapalje had other interests during the time he kept tavern and built a profitable farm. In 1641 he was one of the men called upon to give advice regarding the treatment to be administered to the Indians who had murdered Claes Swits. In 1647 Jan Dircksen from Amsterdam made his will while lying sick at Joris Rapalje's house. Jan was the master carpenter of the ship Swol, and in that will he named Rapalje "Chief Boatswain", not of his ship, but evidently because Joris was using his knowledge of the bays and river around the city.

There is no evidence that the Rapalje tavern was ever cited as a disorderly place. Joris seems to have obeyed the laws and honored his promise to abide by them. He died at the age of 59 and was survived by his wife who died in 1689 at the age of 84.
