Deed Book P, page 246: "This INDENTURE, made the twenty fourth day of May in the year of our Lord eighteen and thirty seven, between Frederic Cool and Mary his wife of Washington County, Pa. of the one part and Henry Cowan, Henry Keifer, Isaac Reed, Robert Dungan and David Stephen Trustees of the Frankford Congregation of the other part, WITNESSETH, that the said Frederic Cool and Mary his wife in consideration for the sum of Forty Five Dollars to them in hand paid by the said Trustees, the receipt whereof is hereby acknowledged, have granted, bargained and sold by these presents unto the said Henry Kown, Henry Kiefer, Isaac Reed, Robert Dungan and David Stephens, Trustees as aforesaid and their successors in office forever in trust for the use of said congregation, a certain lot of ground adjoining the lots owned by said congregation bounded as follows, viz: beginning at a post at the North East corner of a lot owned by Nickelson, thence by land of said Cool North 18 degrees East 4 perches and four-tenths perches to a post, thence North 3 degrees West 9 perches to a post, thence South 87 degrees West 4 perches and four-ninths of a perch to a post, thence by lots of said congregation South 3 degrees East 9 perches to a place of beginning, containing forty perches strict measure.



## FRANKFORT SPRINGS, PA.

From "History of Beaver County, Pa." by Rev. Joseph H. Bausman, 2 Vols., - page 831:

"Frankfort Springs was incorporated into a borough by a special act of Assembly, approved March 19, 1844. Section 1: That the town of Frankfort Springs in the county Beaver, a territory included within the following boundaries, to wit, beginning at a stake on the county line near Robert Leeper's barn, thence north 144 perches to a stake on land of William Frazier; thence east 182 perches to a stake on land of John Carothers, thence south 144 perches to the Washington County line; thence west on the county line to the place of beginning, is hereby erected into a borough, which shall be called and styled the borough of Frankfort Springs." (P. L., 142)

REBECCA KNOX, died June 21, 1851, aged 69 yrs. and 9 da.
Wife of Andrew Knox, who died prior to 8 Aug. 1862. (Andrew Knox appointed postmaster 25 Jan. 1836, Frankfort Springs Borough. He was a witness to MARY COOL's will.
He owned land bounded by James McCown (McKown) heirs, Washington & Georgetown Road, JOSEPH WITHROW and MRS. JAMES DUNGAN, widow of James Dungan.) HENRY KEIFER born 22 May 1794, died December 1878. Married Mary Ann Smith 29 February 1822. They resided in Allegheny County, Fa. for several years. Moved to Beaver County, Pa. with three little girls, one of whom (Jane Moor Keifer) died in her seventh year. Henry Keifer was a trustee of the Frankfort Congregation. Farmer. Henry and Mary Ann Smith Keifer had a son David, who enlisted as a private in Co. H, 140th Reg. Pa. Vol. August 22, 1862. He escaped injury even though he saw some hard service (Civil War). When his company was returned he sat down by a tree to rest and was found dead hours later by his friends. He had evidently been murdered, as his watch and money were gone. He was buried near where he was found, in a coffin made from the pews of a nearby church. Killed at Farmville, Va. 7 April 1865. Henry and Mary Ann Smith Keifer were parents of HENRY H. KEIFER. (No tombstone presently)

"SILAS CROSS (1815-1851) was son of James Cross, pioneer, who died in 1836, builder of Cross stone house. Silas' mother was Eleanor Gordon. His grandmother was Martha Cross-Doty, died 1819. She was mother of James, Anne and Mary (wife of one James Hindman). SILAS married a Miss Parks, sister of one James Parks. People lived near Florence, Pa. They inherited from James Cross the south 100 acres of Haywood tract (Beaver Co., Pa.), lived there until 1851, time of death of both SILAS and Baby HUCH PARKS CROSS, who are buried at Frankfort Springs, Pa. SILAS' widow, with family, moved to Glenmont, Ohio, farm then owned by lias Cross. Her son James became a teacher and farmer - all descendants of whom are deceased. Her daughter Eleanor, a teacher, married a Mr. Thomas. Her only son became a dentist in Detroit, Mich. His son is now a doctor in Indianapolis, Ind. (1962). The only daughter, Mrs. Eleanor Meyers, is employed by Ohio University and lives in Quaker Heights, Cleveland, Ohio. She has an only daughter, Cynthia Meyers.

"Other members of the pioneer James Cross family: Boston had a farm near New Cumberland, W. Va., moved west. Samuel, Albert, and Clark inherited land from father, James, located in Tuscarawas County, Ohio. Albert and Clark moved west - some into Kansas, others to Iowa. Samuel remained in Ohio - heirs now unknown. John, the youngest, born 1824, became a school teacher. Sister Prudence married a Carson. Her descendants live in Iowa and Washington. Her grandson was Governor of Iowa.

"WILKINSON GORDON CROSS, born 13 March 1813, died January 1859. He was son of pioneer James Cross and Eleanor Gordon Cross. James was a charter member and one of the three first elders in Frankfort Springs Presbyterian Church. They are buried in Three Springs Cemetery, near New Cumberland, W. Va. In 1793 the Haywood tract of land was taken up in name of James Cross. June 4, 1840, WILKINSON married Mary Ramsey, daughter of Robert Ramsey, Jr., son of pioneer Robert Ramsey, Sr. Mary's mother was Susannah Leeper, daughter of pioneer James Leeper. Mary was born 11 November 1816, died 1 Oct. 1893. She was a sister of Robert, William and James Ramsey and a niece of the Rev. James Ramsey, United Presbyterian Seminary professor.

The Levi Dungan homestead, with "L. D. 1799" carved in a basement stone, was razed summer of 1964 to make way for a golf club house. No. 1 tee was to be a short distance below the house, to the right, the side of the original house faced the borough of Frankfort Springs, Pa., on State Route 168. The house was constructed of local-fired red brick, with stone basement walls. It was constructed over a spring. It was built by Levi Dungan on the land patented to him in 1789 and known as "Bachelors Hall", a small portion of which later became a part of the borough of Frankfort Springs. The Frankfort Springs, Fa. United Presbyterian Church lot and cemetery were part of "Bachelor's Hall", as well as the Stevenson (later Rendall) mill (standing 1964), State Route 168 (once known as Washington and Georgetown Road), a few rods from the borough of Fr. Spgs., Fz. The Stevenson mill and the Levi Dungan house were on the same side of the highway, a valley separating them. Some publicity was given to the Dungan house in The Beaver County "Times" of June 26, 1964, published at Beaver, Pa. The pumphlet which accompanied activities of the Beaver County, Pa. sesqui-centennial celebration in 1950 contained a photograph of the house, as it then stood, facing Route 168. The red brick walls were of double rows, with about one inch space between. Log beams, circa 12 inches in diameter, supported the first floor. Two rooms were on the basement level - one the spring "house" room and the other perhaps used for food storage, each with a door facing the boro, of Fr. Spgs., and 30 inch square barred (one of them) windows - one to each room. The spring "house" room was what (in 1964) would be the "front" of the house.

When a boy I liked tohear Jack, who was quite a jolly fellow, talk to my father. Old Beaver County (Pa.) sign boards marked the Jenkins' saw mill. You may see old earth dam below concrete bridge. Stones of house foundation that Jack built may be seen near spring just below old public road down North Branch of Kings Creek. The old Jenkins' home was near a spring above road, which now leads to James Sutherin farm at State line. After death of parents, a daughter, Mrs. Sands of Buffalo, N. Y., was owner. For years farm was known as Sands Station for S. W. Pa. Pipe Lines had storage tanks near bridge and paid \$25.00 yearly rental. Mr. and Mrs. Charley Carpenter lived there for years. Anytime you are down there you might care to see tombstone (marble) - about the 1850 period of Joseph Jenkins in the thicket across road from house that in recent years has been occupied by a colored family from Pittsburgh area." - quote, Mr. Alex Cross - Newcastle, Pa. and Chautauqua, N. Y., June 1964.

Beaver Deed Book 89, page 285, made 15 Dec. 1875. Jackson and wife Easther J. Jenkins of Buffalo, N. Y. to Bazel A. Swearingen - secured to Joseph Jenkins 27 March 1838 by patent. Beginning at stake on State line, by line of CROSS, T. Peterson. Joseph Jenkins and wife had six children: Hooper, Jackson, Reed, Sarah, Milton and Rebecca Jenkins. Hooper died without wife or lineal heirs; Jackson is grantor in this indenture.. Sarah married Joseph Wilcoxon. Ann intermarried with John Stewart. Witnesses: Robert Patton and Samuel Patton.

Beaver Deed Book 47, p. 80, made 29 June 1864, between Jane Jenkins, widow of Joseph Jenkins, deceased; James Lindsey and Rebecca Lindsey his wife- said Rebecca a daughter of Joseph Jenkins -- to David Ingram of Hancock Co., W. Va. - land bounded on west by state line between Pa. and Va., and adjoining lands of the heirs of WILKINSON CROSS, deceased, Joseph Miller and John M. Jenkins. Patented to Joseph Jenkins Oct. 1807.

Beaver Co., Pa. Deed Book 146, p. 157, made 1 May 1894. Jackson and Esther (his wife) Jenkins, formerly of Beaver Co., Pa. to Lenora Sands, wife of Robert Sands of Buffalo, N. Y. Bounded: near Jenkins old mill on waters of Kings Creek - now or formerly of Cross, etc.

Beaver Co., Deed Bk. 78, p. 102, made 5 May 1875. James B. Gibson and others to James Cameron, late of Hancock Co., W. Va. but now of Beaver Co., Pa. (The parties of the first part reserve twenty feet on south east side of said described premises where Joseph Jenkins is buried.) (Beaver Co., Pa. Deed Bk. 45, p. 351 - Jenkins' deed to Joseph Gibson - refers to Burs, mill stones and mill irons belonging to the old mill are reserved.)

Copy of letter to Mrs. RUTH ROBERTS, care of James Dungan, Esq., Post Master at Frankfort, Beaver Co., Pa. (Original in possession of Mrs. Emma Bryte Pollock, King Edward Apts., Pittsburgh, Pa. 15213)

"Faquire County, Virginia 11th of October 1832

"My dear Family:

"When I wrote you from Winchester, I promised to write as soon as I arrived here if I was likely to be detained. I did not write, it being altogether uncertain whether I should not be ready to start home in 4 or 5 days, as the other part of my business would be done in that time. Except what concerns the Negroes - I found the Negroes on the farm of their Master and the time almost Expired that they could remain here without being taken up by the proper authority and solt to the highest bider - under those circumstances I have been prevailed on by their most earnest entreaties together with the desire of Wm. Thompson to remain here until tomorrow, when a Sale of the land will take place, by which means money will be obtained for their Removal to a free State which it appears duty requires me to do. Altho I shall be remunerated for my trouble, etc., I could not have waited for them, could I have believed my duty would have been otherwise discharged.

"I cannot tell what day I Shall be Ready to Start home but certainly not many and when I do Start, Cannot get there in less than double the length of time that I could travel alone - my health is better than it has been for the last Six months, having got clear of my cough.

"Notwithstanding the marked attention I receive from Wm. Thompson and his family and many other Excellent families to which I have been introduced, my Situation has become Extremly irksom on Account of my too long absence from home, but I hope you will all make yourselves as easy as you can and do those things that you believe to be rite.

"I have been to preaching Several Times Since here and if I have ever Seen anything deserving the name of Revival of Religion it is here at this time.

"I went to hear a Wm. Broades on last Monday. There was a meeting House of common sin. One half the congregation could not get in the house. He stood in an outside door and preached.

"And Such preaching and Such attention and Such manifest anxiety I have never witnessed, but I need not attempt a description of the (note - can't decipher EBP). He baptised 17 persons that day and the Weak before 20 at the Same place and if I was to Judge from appearances, there will be many more in a few days - a few days before he had baptised 76 persons in one day about 5 miles from the place I saw him, but those are not Camelites. I must quit, hoping and believing that you will all readily believe that my anxiety to get home far exceeds yours on my account.

"Well, Tommy, have you found your Axe? Well, An Mara, what will you Take for Jane's baby?"

This John Roberts was the son of Richard, and husband of RuthDungan Roberts. An Mara was probably Ann Maria Roberts, his youngest daughter and Jane is probably his first daughter who married James Cameron (1) and mar. (2) Epi Hutton - Jane would have been 28 years old and Ann Maria seven years old. See John Hart Pettit's will. John H. Pettit's wife Catherine Y. Pettit's will was probated 23 January 1832, Faquire Co., Va.

Copy of a letter, original in possession of Mrs. Emma Bryte Pollock, Pittsburgh, Pa., written by JOHN ROBERTS:

"October 16th, 1832 Faquire Cty., Virginia

"I wrote you last Thursday a pretty detailed Statement why I have remained here So much longer than I had Expected. I had also wrote from Winchester but lest those letters may have miscarried, I now write to let you know that I am well, quite well, and that I must Remain here 4 or 5 days yet before I can start home. I Shall Just say, in Short, that it appeared to be my indispensible duty to Stay until those Negroes could be Ready to move out to a free State, and that it was impossible to get their money Collected Sooner. I told you in my last that the Land was to be sold last (missing). It has been sold Since, but they have a large crop of Corn and Tobacco to Sell yet which will Sell Readily when got together, which will be in four or five days and we have Everything Els now Ready. I still Receive the most flattering attention and Respect from W. Joseph Thompson and family, together with almost all the best families in this part. Am Constantly Solicited to Spend more time with them than I have to bestow on each, but I am not in a State of mind to enjoy Company, knowing that you are unesy on my account, which Renders me very unhappy.

"I trust you will all try to do those things that you think Rite and make your Selves as Easy as possible and console your Selves by knowing that I shall bee Rewarded for my time.

"If you have not got the under Story of the House plastered, if you can get it done Conveniently, I think you had better do it. I have had some uneasiness for fear Jese mite wish to Start down the River before I get home, but I hope to be there before he is Ready. Those Negroes are all to go out with me and one of their wives, which we have purchased at three hundred and fifty dollars.

"If I am detained longer than one weak more, I will write again, but I do not think I Shall.

"Hoping and believing that you will make your Selves as easy as possible, and I will do the same, I remain, as ever,

See will of John Hart Pettit, brother-in-law of RICHARD ROBERTS, uncle-in-law of above JOHN ROBERTS. HENRY WILSON was one of the slaves brought out by JOHN ROBERTS to Beaver Co., Pa.

The widow of John H. Pettit, Catherine Pettit, made 17 Aug. 1831, recorded 23 January 1832, Faquire Co., Pa. carried out her husband's wish: "Item 2nd. I give in trust, to my Executor hereafter named for the benefit of my slaves (who are to be free after my decease by the will of my late Husband, John H. Pettett) with my consent, the following property, viz; 1st For the benefit of HENRY WILSON - I give all the money, Bonds, notes and accounts due me at the time of my decease - also his two choice Horses, three choise cows and calves, six choice sheep, his choice of one half of the Household and Kitchen furniture, a saddle and saddle bags with fourteen dollars, one third of the wheat, corn, Tobacco and Bacon on hand, also one third of the growing crop, if any then be at the time of my decease, and third part of the farming utensils, also a lot of land that I purchased of Frances Settle, containing Forty five acres more or less adjoining the land of my late Husband, John H. Pettett, this land or the profits thereof to go to HENRY WILSON and enjoyed by him during his life - after the death of Henry Wilson the said land to be sold for the best price it will command by my Executor and the proceeds thereof to be given to the Colonization Society, etc. ... but should Henry Wilson see cause to remove and settle himself in another state, my Executor may surrent to him the whole of the above property intended for him (except the land), to be enjoye by him in perpetuity." Rest of estate in trust to Exec. for benefits of the servants,

Excerpts from will of John Hart Pettit, Fauquier Co., Va. (Will Bk. 12, p. 21, filed Warrenton, Va. He was brother of Mary Pettit-Gordon Roberts, wife of Richard Roberts. "In the name of God amen, I, John H. Pettit of the County of Faquire and state of Virginia .....

"Item: To my wife Catey Pettit I give and bequeath the use profit and benefit of all my Estate real and personal for the term of her natural life, except such parts thereof as are Specifically disposed of hereafter and excepting also my negro Slaves which I give to her only during her widowhood only, my stock of every kind together with my farming utensils and Household and Kitchen furniture, and all grain and provisions at hand at the time of my death I give to her in perpetuity, to be used and disposed of as she may think proper and it is distinctly to be understood that my wife has the right to hire out any of the negroes at any time during her widowhood, but if she should thinl proper to marry again after my decease, then my will is that my Executors take all the Slaves into their own possession, and hire them out to such humane persons as they may think proper and pay the amount of hires to my wife Catey for her use and benefits annually.

"Item: It having been my firm opinion that all human beings have a right to their freedom (unless they have forfeited it by crimes), I cannot reconcile it to my conscience not to do something to ameliorate the condition of the slaves I possess. My will, therefore - expressly is, that my negro slaves, to wit, George, Hannah, Simon, Henry the elder, otherwise called Hendley, and Henry the younger, called also Henry Wilson, together with all others that may be my property at the time of my death, shall at the death of my wife Cathy be free and as perfectly entitled to their liberty as the laws of the land will permit and whereas the Laws of this Commonwealth do not admit of Negroes now freed remaining in it longer than twelve months after the Commencement of their freedom, I request my wife Catey to make some provision in her will (in addition to what I have done) for a removal of them to a place where they may better enjoy their liberty, and I hereby declare that nothing in this will shall be so construed as to prevent her (or my executors with her consent) from removing them or any of them for such purpose during her lifetime. But if it should so happen that they do not remove but remain in this neighborhood, then in that case I request all my neighbours and friends, and all persons who shall be come acquainted with the contents of this will, for the sake of Humanity or for any regard they may have had for the Testator, to suffer them the said negroes to remain undisturbed and enjoy their freedom as long as they continue to behave well. And I recommend and enjoin it on my Executors after the decease of my wife to inform the said negroes of their true situation, and the laws then in force concerning them and the nearest and best place for them to remove to; and in fact to consider them as under their particular care and guardianship and particular so with regard to the Boy Henry Wilson.

"Item. To my nephew John Walden (son of my sister Nancy Walden) who now lives near the village of Bloomfield, Jefferson County, State of Ohio, I give and bequeath the sum of one hundred dollars with a request that he will come to this County after the decease of my wife, and assist my negroes (if any of them can be persuaded to go) to the State of Ohio or other place where they can enjoy their Liberty, and that he also assist them as far as may be in his power after their arrival at such place, particularly the Boy Henry Wilson, as I think he may very safely be his security for his good behaviour if that is required, as I think the Boy is of a good disposition and sound principles as far as a Boy of his age and opportunity is capable of attaining them, but this is not made a condition of his receiving the \$100.00 further than that he must come for the Legacy himself and endeavor to get the Boy to go with him to Ohio or Pennsylvania or some free State.

John Hart Pettit will -- continued:

Will of John Hart Pettit, Fauquier Co., Va. continued:

"Item. To my Executors hereinafter named, I give and bequeath the sum of one hundred dollars as a further remuneration for their services beyond what the law allows them, to be equally divided amongst them if they all act, and if they should not all act, then the whole to go to those that do act. I also give to my acting Executors in trust for the benefit of the above negroes the amount of all Debts due me at the time of my death, together with what money I may have on hand at that time, to be retained in the hands of my Executors or put out to Interest (not exceeding 6 pr. cent pr. annum) and if my executors retain the money in their own hands it is expected they will allow the same Interest (not exceeding 6 pr. cent) as could be obtained from other good responsible men. At the decease of my wife, this fund together with my land not specially devised to my wife, it to be applied to the removing my negroes as mentioned above if they are willing to be so removed, and if not, the money, land, etc. are to be retained in the hands of my Executors and held in trust for their benefit, for the purpose of maintaining such of them as my become unable through age or infirmity to maintain themselves comfortably, my great desire being that they may be comfortably maintained and protected from injustice, and my Executors are hereby empowered to use the said fund for these purposes at their discration, and also to seat the said Negroes on my land if the thing be found practicable, they (my Executors) are also expowered and requested to do more for the Boy Henry Wilson than for any of the others, is mother having been a faithful servant, he her only living child and raised in our family.

"Lastly, I constitute and appoint my Friends, John C. Cummins, Elijah Hansbrough and Jos. Thompson to be the executors of this my last will and testament, and my desire is that the funds designed for the benefit of my negroes be used liberally by my Executors for that purpose, and I recommend assistance be formished them in such necessaries as they may stand in need of rather than in money.

"Recapitulation: etc. Signed: John H. Pettit (Seal)
"Attested by us in presence of the above John H. Pettit and at his request:
Reason H. Oliver John S. Conway Jonathon Cooper John Oliver
Codicil

"I, John H. Pettit, in the foregoing last will and testament having further considered the same, do think proper to make and publish the following Codicil an addition thereto. .... Having in the body of my will made in July last left a sum to my acting Executors in trust, for the purpose of removing my negro slaves after the decease of my wife (or sooner if she agrees to it) to a place where they may better enjoy their freedom or support them here as the case may be. Now, having considered that there are no children among them nor likely to be any, I think it probable that there will be a surplus left after there are no subjects needing it. Therefore, I give and bequeath such remaining surplus to the American Colonization Society with a view of aiding them in their Benevolent plans of Colonizing the free people of Color with their own consent. The Tob<sup>o</sup> (Tobacco) on hand at the time of my decease the not mentioned in my will is left to my wife and this is hereby declared to be my intention.

"Given under my hand and seal this 28th day of August one thousand eight hundred and thirty.

"At a court held for Faquier County on the 28 February 1831, the last will and testament of John H. Pettit, Dec'd. was proved by the caths of Reason H. Oliver and John Oliver.

JOHN ROBERTS Son of J and M Roberts, died 12 February 1812, aged 5 yrs. 9 mos. 10 days. (On same tombstone as Emeline Roberts).

RICHARD ROBERTS 8th Virginia Line, Revolutionary War.(U.S.Govt. marble marker) Born vicinity Flat Run, Mountain Run, present Kelly's Ford, Culpeper Co., Va. 1755.

Married in Va. Mary Pettit (Gordon), dau. of Obediah and Ann Hart Pettit of Faquire Co., Va. She had one child Elizabeth, born July 1, 1776 to a Mr. Gordon. (The Pettits were of Huguenot ancestry; from France to England to America in the early 1630's. Exeter, N. H.; 3oston; Newtown in Queens Borough, Long Island, N. Y.; Trenton, N. J.; Faquier and Culpeper Counties, Va.; a brother of Mary Pettit Gordon Roberts owned land for a few years in Cross Creek township, Wash. Co., Pa. and moved on to Kentucky.

RICHARD ROBERTS enlisted 26th or 27th of January 1776, in Culpeper Co., Va. with Henry Field, Lieutenant of Capt. George Slaughter"s Company of the Eighth Virginia Regiment (Col. Muhlenberg and Col. Bowman's Regiment) and was honorably discharged at "a place called Valley Forge, Pa." February 3, or 5, or 6, 1778. (Note: Col. Muhlenberg, Lt. Col. Abraham Bowman received their commissions as officers, March 1, 1776. The 8th Va. Regiment became known as the "German Regiment" - its officers and men were almost without exception from German families of the Shenandoah Valley. See "The Fighting Parson of the American Revolution," by Edw. W. Hocker, Philadelphia, Pa. 1936).

RICHARD ROBERTS and his wife MARY ROBERTS were parents of:

JOHN ROBERTS (See John Roberts "Pioneer") Born Virginia

Richard Roberts, Jr. b. June 30, 1782, married Ann Saunders (Mar. 11, 1787 - 1885) dau. of Benjamin Saunders of Virginia. They owned and lived on land in Brooke (now Hancock Co.) County, (W) Virginia and the family moved to Richland Co., Ohio in 1828. Richard and Ann Roberts children were: Elizabeth, Obediah, David, Richard, William, Nancy Ann, Thomas, Benjamin, George, Polina (b. May 18, 1822, mar. Simeon Tucker and had Amelia, Sylvester, Joseph and Martha), and John. Richard Roberts, Jr. born Va., died Ohio 8 Dec. 1858.

Mary, born August 12, 1787, Virginia
Ann Roberts, born Oct. 30, 1789, died Oct. 19, 1824 Born Va.

Margret Roberts, born July 22, 1791, Virginia. Obediah Roberts, born Sept. 29, 1793, Virginia.

According to "Culpeper Co. Personal Property Tax" on record Richmond, Va., State Library RICHARD ROBERTS was taxable April 3, 1790 - 1 white tithable, 2 horses. Same tax area as Joseph Roberts, Joseph Roberts son of George, John Barrow. He was on tax list through 1793, the last year taxed: on one white tithable, 3 blacks above 16 - and was taxable including year 1798. March 22, 1804, he purchased 254 acres in Brooke (now Hancock County) county, (W) Va. of Jonas Seely - Seeley had purchased part of the Cornelius Quick patented land (Common. of Va. to Quick, 400 Acres 17 April 1798). The 254 acres were bounded: on line of a survey made for William Barr, corner Thomas Peterson, corner to James Cameron, corner to Thomas Peterson. This was on the waters of Kings Creek, near the present Pennsylvania state line. (It is believed (1964) that Mr. and Mrs. James Hukill, R. D. 1, Weirton, W. Va. own and live on part of the 254 Acres it is known that Alex. and Mary Jane MORRISON sold to LEVI STANDISH in 1877. Later owners have been James Scott, Edmond Vaughn. A mill wheel near the Hukill's house was from the Levi Standish mill, according to Mrs. Hukill. Lt. Col. Warren Scott Dungan stated he understood Richard Roberts and his wife Mary are buried on that farm.

Richard Roberts - continued:

RICHARD ROBERTS 8th Virginia Line, Revolutionary War ... continued While a resident of Brooke (now Hancock) Co., Va. he applied for Revolutionary War pension and received eight dollars per month. Sometime between Oct. 18, 1823 and 1828, he removed to Hanover Twp., Beaver Co., Pa. A letter from John H. Pettit, Faquire Co., Va. to Richard Roberts - brother in law - was addressed to Frankfort P. O. Beaver Co., Pa. in 1828. In January of 1829 he made a will, but his final will was dated December 25th, 1829 and reads: "I leave JOHN ROBERTS to devid what few things I leave in the foloing manner, viz: the Horse for yourself, old Muly Ruthe must keep, the white mule Jese must have for takeing care of me. Poly must keep the cow she has and she must have the bed I ly on. Margret must have the new coverled and Obediah the other white heafer and old mules spring calf. Giving under my hand this 25 Day of December 1829.
