The Early Murchlands

The Brooke County Murchlands have their beginnings in Killyleagh, County Down, Ireland. There it is recorded in the Presbyterian Church Records that William Murchland married Elizabeth Marshall, 19 February 1706. They were the parents of the James Murchland whose descendants are the subject of this research. The records of the marriage of Jennet Murchland, 1 July 1698, to William Murdogh, and of Martha Murchland, 27 April 1699, to William Russell, lead to the possible conclusion that they were sisters of William, having given names commonly found in the Murchland line.

The James Murchland with whom this manuscript is concerned was baptized 11 January 1708, having been preceded by his older sister, Mary, on 24 9ber 1706. He was followed by his sister, Christian, on 5 March 1710, by twin sisters, Jennet and Elizabeth on 26 April 1711, and by his brother, William, on 24 April 1713. After the birth of William, the mother, Elizabeth Marshall Murchland, died. William remarried on 20 8ber 1715 to Margaret Boyd, by whom he had the following children: Martha, Thomas, John, Ann, Jane, Susanna, and Joseph – the last of whom was baptized 11 April 1732.

James Murchland who was baptized 11 January 1708, married Elizabeth Shaw, 30 10ber 1731. Their first five children are numbers 1 through 5 under First Generation in the following document. Their other children were Susan, Mary, Ann, James, and a child who is nameless who was baptized 14 9ber 1756. It is not known if they or any of their descendants came to America. What IS documented, is that #s 3,4,and 5 – namely, William, Christian, and Robert – DID come to America. It is highly probable that at least one descendant of Sarah(#1) and of Elizabeth(#2) also emigrated. Because of this high probability, they are included in the text of this manuscript.

NOTE: In the Irish baptismal records listed above, there is another child of James Murchland listed as being illegitimate, having a mother named Maryann McMurrans. This child is named Isabell and was baptized 16 January 1737. Since James was married to his wife, Elizabeth Shaw, at the time, and since she gave birth to their son, William, just two months after this illegitimate birth, this poses a puzzle as to exactly what the circumstances were in the Murchland household at the time. It should be noted, however, that Elizabeth apparently continued to live with her husband after this unfortunate affair, since she bore him seven more children.

Documentation: Information for the above material was given to this researcher by Joan Tefertillar. It originated with Margaret Williams of Oakville, Ontario, Canada, and is the result of her personal research in County Down, Ireland.

The Murchland Journey to America

The Murchland immigration to Brooke County, VA, appears to have been in this manner. Robert Murchland (#5 in the following manuscript), son of James and Elizabeth Shaw Murchland, came to America from Belfast, Ireland, on the ship "Peggy", landing in Philadelphia in June of 1773. He eventually came to what is today Brooke County, WV, and took up a large tract of land. In 1790, he sent for many of his family. Included in this large migration were his brother, William(#3), and sister, Christian Murchland Lawthers(#4), their spouses and families. This is believed to have been a party of at least 20 persons. (It is possible that William's son, James(#8), was not among them since a granddaughter of his at a much later time wrote that he had come in to New York.) This journey was made on the brig "Brothers" and consumed a time of seven weeks and three days. It arrived in Baltimore, Maryland, where they rested for three months time until Robert(#5) was able to bring a train of pack horses from his home in Brooke County to transport them across the mountains. Among those waiting to greet him was his mother, Elizabeth Murchland, who most certainly was nearly eighty years of age. It had been 17 years since Robert had last seen his mother when he left the Emerald Isle in 1773. Unfortunately, no other tales of their hardships, joys, and sorrows has survived.

First Generation The Children of James and Elizabeth Murchland

Sarah Murchland, baptized 21 January 1733 in Killyleagh, County Down, Ireland; married Hans Steen, 20 April 1752.

+6 James Steen, b. 1756, in Province of Ulster, County of Londonderry, near Culmore, Ireland. (NOTE: +sign indicates more information will be given under same name in the following generation)

James Steen arrived in Philadelphia in February, 1776, and joined the Continental Army on April 28, 1776. At the close of the war, he married Margaret Reynolds, circa 1783. By 1787, he is in Brooke County, VA, where he is listed in the Brooke County, VA 1787 Tax List. He died between June 16, 1831 and March of 1833 in Cross Creek Township, Washington County, PA; buried at Tent Cross Creek Cemetery, Brooke County, VA. His wife, Margaret Reynolds Steen, died between 1820 and 1830, and is buried beside him.

NOTE: There is NO documentation to prove that the James Steen documented above was the son of Sarah Murchland. James Steen named his eldest daughter Sarah, which may have been in honor of his mother. IF a Murchland were James Steen's mother, then it was PROBABLY Sarah who married Hans Steen. The rationalization for assuming any of this is based upon the information in the will of Robert Murchland(#5), Brooke County Will Book 1, Page 1. Robert, unmarried, left his land holdings to two sons of his brother, William(#3). They were to pay the other two sons and three daughters a specified share from the profit of the land. The profit from his household goods, etc., he left to the children of Alexander Lawther and James Steen. The remainder of his estate such as debts owed him, plus ALL of his money, he left to be equally divided between Alexander Lawther and James Steen. It is a proven fact that Alexander Lawther was the husband of his sister, Christian. Thus, Alexander Lawther's children would be the nieces and nephews of Robert Murchland. It is also a proven fact that James Steen, according to The Steen Family, was the only one of his family to come to America from Ireland, and thus would no doubt have been the only Steen to receive an inheritance in America. In a number of old Murchland papers, it is repeatedly written that back in Ireland the Murchlands and the Steens were cousins. To this writer, it is most logical that the connection between the two families is that James Steen's mother, like Christian Murchland Lawther, was a sister of Robert Murchland, and thus it was natural for Robert Murchland to divide his property between both Robert Steen's and Alexander Lawther's children. It is UNLIKELY that he would have left half of his estate to the children of persons not very closely related to him. However, this assumption may not be correct.

NOTE: Near the end of his will, Robert Murchland(#5) makes this puzzling statement: "and further the said Alexander Lawther and James Steen is to pay unto Easter Muckleroy three pounds each of them, Pens money, in six months after my death, and further I leave to William Muckleroy's son James a brindle heifer with a white face...". Under part f) of the Documentation for First Generation is a synopsis of genealogical information compiled by this researcher on a William McElroy, his son James, and wife, Esther. It is very highly probable that the persons named Muckleroy in Robert's will and the persons named McElroy in this documentation are one and the same. If they are, and this is purely speculation, there is still no proof of their blood relationship to the Murchlands. However, a good educated guess would be that Esther is a child of another sister of Robert Murchland(#5), probably this

sister, Elizabeth(#2), who may have died in Ireland before 1790, but whose child, Esther(#7), came to America at that time with the other Murchlands, and later married William McElroy as his second wife. Further insight into this dilemma can be gained by examining the data under Esther(#7) in the Second Generation section of this work. If this speculation is not true, then Esther McElroy was not the child of Elizabeth(#2).

William Murchland, baptized 19 March 1737, Killyleagh, County Down, Ireland; married Jane ______, circa 1763; came to America in 1790 on the brig "Brothers" with his family, and settled in what was to become Brooke County, VA, on the land of his brother, Robert Murchland(#5). He died in Brooke County in February or March of 1813, and is buried in the Murchland Private Burial Ground on the home farm, Brooke County, VA. William's wife, Jane, was probably born circa 1740, in Ireland, and died in Brooke County, Va, in 1804. She is buried in the Murchland Cemetery. Issue:

- 9 Susanna b. after 1765 but before 1784, in Ireland; unmarried; came to Brooke County in 1790; died 1838; buried in Murchland Cemetery.

NOTE: The order of persons 8 through 14 is not necessarily their birth order. It is, however, the order in which Robert(#5), and their father, William(#3), list them in their wills.

Christian Murchland, baptized 26 September 1739, in Killyleagh, County Down, Ireland; married Alexander Lawther, circa 1764; came to Brooke County in 1790; in Cross Creek Township (later, Jefferson), Washington County, PA, in 1800; died between 1800 and 1810; buried probably in the Murchland Cemetery. Her husband, Alexander Lawther, died also between 1800 and 1810, and is probably buried beside Christian in the Murchland Cemetery. Issue: NOTE: Surname of persons 15 through 21 is LAWTHER.

15 John, b. circa 1765 in Ireland, member of Enneskillen
Dragoons; honorably discharged with a pension and lived in

Manchester, England. In 1804 was ordered to Gibraltar; died in 1814 of the Plague; issue: a son who served in the 39th Regiment and two daughters who married and lived in Manchester, England.

- 17 Nancy, b. before 1774 in Ireland; came to Brooke County in 1790; never married; believed to be living with her parents in Cross Creek Township, Washington County, PA, in 1800; believed to have died between 1800 and 1810; is probably buried in the Murchland Cemetery.
- 18 Robert, b. before 1774 in Ireland; came to Brooke County in 1790; never married; believed to be living with his parents in Cross Creek Township, Washington County, PA, in 1800 and with his brother, James, in 1810. In 1820, he is a head of household, living alone, over 45 years of age. He appears to have died after 1820 and before 1830. He is probably buried in the Murchland Cemetery.

- 20 Alexander, b. between 1784 and 1789, in Ireland; came to Brooke County in 1790; never married; believed to be living with his parents in Cross Creek Township, Washington County, PA, in 1800, and with his brother, James, in 1810. He appears to have died between 1810 and 1820, and is probably buried in the Murchland Cemetery.
- 21 Christian, b. between 1774 and 1784, in Ireland; came to Brooke County in 1790; is believed to be living with her parents in Cross Creek Township, Washington County, PA, in 1800; is a head of household with one female child under the age of ten in 1820; married William Patterson at some point in time; no further information.

NOTE: The order of persons 15 through 21 is not necessarily their birth order. It is, however, the order in which they are listed in the source from which the information was obtained.

Robert Murchland, son of James and Elizabeth Shaw Murchland, baptized 3 February 1743 in Killyleagh, County Down, Ireland; unmarried; came to America from Belfast, Ireland, on the ship "Peggy", landing in Philadelphia in June of 1773, after a journey of seven weeks. Took up land in what was West Augusta District, VA. (In 1776, this became Ohio County, VA, and in 1796, became Brooke County. Robert Murchland's land in the year 2000, is known as Puntney Ridge and is on the waters of Cross Creek.) In 1790, he sent for his entire family including his aged mother, Elizabeth Shaw Murchland. They arrived at Baltimore, Maryland, where they remained for three

months. Robert then took a train of pack horses to bring them across the Allegheny Mountains to his Virginia home. He died 17 March 1797, and is buried in the Murchland Private Burial Ground on his farm.

Documentation for First Generation

- a) The names of the children of William Murchland(#3) are taken from the will of Robert Murchland(#5), Brooke County Will Book 1, Page 1. Birth dates for Susanna and Mary were calculated from census listings and may be inaccurate, since their appearance in the early censuses is pure speculation. However, tombstones in the Murchland Cemetery were copied by four different persons at four different points in time and death dates for Susanna, John, and Mary are taken from those cemetery listings. Susanna and Mary still bear their maiden names on their tombstones. John is living with a nephew, Robert Jr., in 1860, and appears to have remained unmarried.
- b) Information on James Steen(#5) is from <u>The Steen Family in Europe and America</u> by Rev. Moses D.A. Steen published by Monfort & Company, 1917, p. 530.
- c) Information on Robert Murchland(#5) is from a 1992 issue of the magazine, <u>Ireland of the Welcomes</u>. It is a copy of a letter published in a Belfast Newspaper in 1773, thanking the owner of a shipping company for safe passage to the New World. It is signed by the passengers, among whom is Robert Murchland.
- d) Information on Christian Murchland Lauther(#4) is from

 Biographical Record of Carroll County, Ohio by J.H.Beers &

 Company, 1891, pp. 1031 1033. Also included in these pages is
 the story of the Murchland-Lawther family voyage to America in
 1790. Death dates of Christian's children are calculated from
 census records, and are, at best, probable. Both Brooke and
 Washington County death records and cemetery listings were
 consulted for Lawther deaths and burials, but none of those in The
 First Generation were found. Since the Murchland Private Cemetery
 contains a great number of early graves which were unmarked at
 the time the tombstone inscriptions were copied, it seems safe to
 assume that this generation of Murchlands and Lawthers, as well
 as many of their children, are buried there.
- e) The father of this first generation, James Murchland, was born in Ireland and probably died there before his family made the journey to the New World in 1790. The mother, Elizabeth Shaw Murchland, came with them to America. She does not appear in the 1800 Cross Creek Census with the rest of her family, so it would appear that she died in either Brooke County, VA, or Washington County, PA, (while living with her daughter, Christian Lawther) before 1800, and is no doubt buried in the Murchland Cemetery on the land of her

- son, Robert(#5). There is a discrepancy in the information consulted as to the maiden name of Elizabeth. Carroll County history lists her as Elizabeth Crawford Murchland. But marriage records of the Presbyterian Church in Killyleagh, County Down, Ireland, state that James Murchland married Elizabeth Shaw 10ber 30 1731. Their first child was born in January of 1733. Since this is a church record, this researcher has chosen to use the name "Shaw" rather than the Carroll County history listing of "Crawford". It is, of course, possible that her maiden name was Crawford and that she had married a man named Shaw before her marriage to James Murchland.
- f) A William McElroy was born in Ireland circa 1754. Census records of Jefferson County, Ohio, for 1820, 1840, and 1850 bear out this information. According to The History of Belmont and Jefferson Counties, Ohio by J.A.Caldwell, 1880, page 599, William came to this country with his father at the age of six. No mention was made of his mother or of any siblings, and there is nothing more in the way of information on his father. William served in the Revolutionary War and married perhaps circa 1773 since his only child, a son, James, was born circa 1774 in Pennsylvania. According to History of the Upper Ohio Valley by Brandt & Fuller, 1890, page 397, he came to Virginia at some point in time and left there in the spring of 1797 and crossed the Ohio River. He is listed as being one of the first settlers in Cross Creek Township, Jefferson County, Ohio. He cut his way from Steubenville through the woods to Section 24 in that township, remaining on his clearing a number of years. He then secured a deed which was signed by Thomas Jefferson and Bazaleel Wells for a piece of nearby property. This was in the year 1807. This land remained in the McElroy name for several generations. William is believed to have died at the age of 100 and is buried in Two Ridge Cemetery, Island Creek Township, near Wintersville, Ohio. Buried near him are his only child, James McElroy, and James' wife, Esther McElroy. (It is interesting to note that William had left Brooke County, VA, in the spring of 1797, which coincides with the death of Robert Murchland(#5).)
- g) Baptismal dates for persons #1 through #5 are from the Presbyterian Church Records in Killyleagh, County Down, Ireland, and are the result of research done by Margaret Williams of Oakville, Ontario.

James Steen (Sarah,1), b. 1756, in Province of Ulster, County of Londonderry, near Culmore, Ireland; married Margaret Reynolds circa 1783; died between June 16, 1831, and March, 1833, in Cross Creek Township, Washington County, PA; buried at Tent Cross Creek Presbyterian Church, Brooke County, VA.

NOTE: The Esther who married William McElroy has the birth, death, and burial statistics listed above. There is no proof that she was a child of a sister of Robert Murchland(#5). The reasoning for including such a possibility is the fact that in his will, Robert Murchland(#5) left Esther McElroy, wife of William McElroy, money to be paid directly to her. It would thus appear that she is some close blood connection of Robert – probably a niece, since he left legacies to his other nephews and nieces. It is also a possibility that William McElroy himself may have had blood ties to Robert Murchland(#5), since Robert left James McElroy, son of William, a small remembrance in his will. William

McElroy was born in Ireland circa 1754 and came with his father to America about 1760. His mother probably had died before 1760 since there is no mention of her having come with them. She could have been an older sister of Robert who was born in the 1730s. (Baptismal records show four other sisters, one of whom was born in 1737.)

James Murchland (William,3), b. between 1765 and 1770 in Ireland; came to America probably in 1790; married Isabelle Hamilton circa 1798; died August ,1846, in Brooke County, VA; believed to be buried in the Murchland Private Burial Ground. His wife, Isabelle Hamilton Murchland, was born 21 September 1772 and died 14 March 1852. She is buried in the Murchland Private Burial Ground.

- 32 William Murchland, b. 12 July 1799, Brooke County, VA; unmarried; died 16 September 1883, Brooke County, WV; buried in Ebenezer Baptist Cemetery, Brooke County, WV.
- +33 Mary Marguerite Murchland, b. 28 February 1802, Brooke County, VA.
- +34 Jane Murchland, b. 10 April, 1804, Brooke County, VA.
- +35 Mary (Polly) Murchland, b 11 March 1805, Brooke Co., VA
- 36 John Murchland, b. 1808, Brooke County, VA; unmarried; died 7 January 1837, Brooke County, VA; buried in Murchland Private Burial Ground. NOTE: There is no proof that the John Murchland listed here as #36, is really the son of James & Isabelle Murchland. His tombstone gives the facts listed, and since James and Isabelle are reputed to have had 13 children, this John is very likely their son. He is not listed among their children in the Agreement of Dower of 1847, but of course he would not be listed if he were this John, having died in 1837.
- 37 Infant Male Murchland, b. circa 1810- 1820; based on Census Records and tradition which reported that James and Isabelle were the parents of 13 children.
- +38 James Murchland, Jr., b. 22 October 1813, Brooke County, VA.
- +39 Elizabeth Murchland, b. 17 January 1815, Brooke County, VA.
 - 40 Ellen Murchland, b. 7 July 1817, Brooke County, VA.; unmarried; died 21 October 1876, Brooke County, WV; buried in Ebenezer Baptist Cemetery, Brooke County, VA.
- +41 Susannah Murchland, b. circa 1819, Brooke County, VA.
- +42 Sarah Murchland, b. circa 1820, Brooke County, VA.
- +43 Isabelle Muchland, b. circa 1821, Brooke County, VA.

William Murchland, Jr. (William,3), b. circa 1768 in Ireland; may have married in Ireland; came to America in 1790 with the other Murchlands; died 20 June 1818 in Brooke County, VA; is buried in the Murchland Private Burial Ground. If William Jr. married while still in Ireland, his wife may have died there after the birth of a daughter, Sarah Ellen Murchland. Another scenario is that she and Sarah Ellen may have come with the Murchlands to America in 1790 where the wife died before 1810 when she would have shown up in the census records. NOTE: There is no documentation for this theory. It is based on the fact that a Sarah Ellen Murchland, born in Ireland circa 1785, came with the other Murchlands to America in 1790, married Robert Steen circa 1813. This researcher has been unable to place the parents of Sarah Ellen, unless she is the daughter of William(#10). This assumption is based on two premises: first, one of her two sons listed in the 1830 Census, appears to have died before 1840, but the remaining son was given the name of William Murchland Steen, which is probably her father's name; and second, in the will of Robert(#5), this William(#10) is not given any of the land, but rather is to be given money from the estate. Could it be that Robert(#5) saw that William had only his daughter, Sarah Ellen, as an heir and perhaps showed no interest in marrying again? Robert(#5) had four of his brother's sons to choose from in assigning the land. He chose James, the eldest, and Robert, the youngest. Perhaps in Robert's mind, he wished the land to remain in the Murchland name and he may have felt that William(#10) was a poor choice, having only a daughter and little prospect of a son. Issue:

Robert Murchland (Wiiliam,3), b. 1782 in Ireland; came to America with his parents in 1790; married Sarah Henderson circa 1812; died 12 December 1863, Brooke County, WV; buried in the Murchland Private Burial Ground. His wife, Sarah Henderson Murchland, was born 10 November 1787 and died 10 February 1850.

Elizabeth Murchland(William3) b. circa 1785 in Ireland; probably unmarried; may have died 4 December 1849. NOTE: The wills of both Robert(#5) and William(#3) list Elizabeth last among the seven children of William(#3), at least last among the three sisters. It is impossible from the early census records to determine precisely who is being counted. Elizabeth may or may not be the youngest female in William's household in 1810. This could be Sarah Ellen(#45). The reason for such a dilemma concerning Elizabeth is that before her brother, Robert(#13), died in 1863, he stated in his will that tombstones were to be erected for his sisters, Mary and Susannah. There is a tombstone in the Murchland Private Burial Ground which says "Elizabeth Murchland died 4 December 1849". If this is Elizabeth(#14), why did Robert not mention her as needing a stone also? Or is this the stone of some other Elizabeth Murchland? If so, did Elizabeth(#14) marry and is buried somewhere beside her husband who would have provided her grave marker?

James Lawther (Christian, 4), b.15 March 1769, in Ireland; married Jennette Shaw in County Antrim, Ireland, in 1790; set sail on their wedding day for America with a number of Lawther and Murchland relatives; settled in Brooke County, VA, on the farm of his Uncle Robert Murchland (#5), where he lived until sometime between 1800 and 1810 at which time he moved near his parents, Alexander and Christian Murchland Lawther, in Cross Creek Township, Washington County, PA. He died there 23 December 1821, and is probably buried in the Murchland Private Burial Ground. (One person who copied that cemetery reported a headstone which simply read "J.L.") His wife, Jennette Shaw Lawther, was born in Ireland circa 1773, and died on the Lawther farm in Washington County, PA, between 1850 and 1860. She is probably buried beside her husband.

- + 56 Eleanor Lawther, b. June, 1791, in Wells Fort, Brooke County, VA. during an Indian raid.
 - 57 Christian Lawther, b. circa 1793, Brooke County, VA; m. Charles Long prior to 1820; lived in Cross Creek Township, Washington County, PA, until after 1830, at which time they had a son and three daughters. No further information.
- + 58 John Lawther, b. 11 June 1796, Brooke County, VA. 59 Jane Lawther, b. 1801, Brooke County, VA; unmarried; died

October, 1877; buried at Bethel Methodist Cemetery, Jefferson Township, Washington County, PA.

Her husband, James Puntney, was the son of James Puntney, Sr. and was born in Maryland in 1805. He died in Brooke County, 11 March 1888, and is buried beside his wife. Issue:

- 131 James Murchland Puntney, b. circa 1837, in Jefferson County, OH; never married; returned with his parents to Brooke County in the mid 1850s to the old James Murchland Farm. Alexander Lawther, (James,16), b. 22 June 1808, Brooke County, VA; moved with his parents to the Jefferson Township area of Washington County, PA, when a very small child. - c) Information for the children of Robert Murchland (#13), that is, #s 46, 48, 49, 50, 51, and 52 are from the Murchland files in the keeping of Elwood Moore and the late Albert Miller, which are comprised of cemetery listings of tombstone inscriptions by early Murchland descendants, probable genealogies as composed by Bertha McConnell and other descendants, and a large host of miscellaneous information compiled over many years by interested persons. The information for #47 is from the John H. Murchland Family Bible. Children of #53 and 54 are from census records and cemetery listings.
- d) Information for descendants of James Lawther (#16), that is, #56 and 58, are from the files of Steve Leeper; from Leesville Cemetery listings; from the files of L.David Johnson; from Biographical Record of Carroll County, Ohio by J.H.Beers & Co., 1891, pp. 1031-1033; from old newspaper clippings and obituaries. The information for #61 is from census records. The information for #62 is from Bethel Cemetery readings; census records; The Robert McCready Family by Robert J. McCready, M.D., 1931; The

Commemorative <u>Biographical Record of Washington County</u>, <u>Pennsylvania</u> by J.H. Beers, 1893, page 686; and old obituaries. NOTE: The information listed in <u>The Steen Family</u> concerning Ellen Lawther(#257) is incorrect. It is correct in this manuscript. The above mentioned genealogy lists Ellen as the mother of some of Robert Cunningham's children. This is not true. Her obituary and a number of other documents substantiate the fact that ALL of his children were children of his first wife.






