1. JOHN¹ WHITE was born 1760 in Ireland, and died 08 Jun 1846 in Lancaster City, Lancaster County, Pennsylvania¹. He married CATHARINE SPROUL 24 Oct 1789². She was born Abt. 1761 in Ireland, and died 02 Jul 1843 in Lancaster City, Lancaster County, Pennsylvania, United Stated of America.

In this book are the epitaph of John White Jun'r on page 147 (listed in this history under his name) and list of the Members, including the White family members, of the Middle Octorara Presbyterian Church, which was established August 7, 1727 by a group of Scotch-Irish settlers, and described below:

On page 53, the following notes: Minutes in the book containing the minutes of the Sessions during the pastorate of Reverend Joseph Barr (1823-1844) who succeeded Reverend Samples as pastor of Middle Octorara Church. "Roll communicants at beginning of Reverend Joseph Barr's pastorate" (1823). They were therefore members during the Sample pastorate: we suppose most of them unite with the church under his guidance (1781 - 1821 pastor).

This John White was my Great grandfather. He was married Oct 24th 1789 to Catharine Sprowl who died July 2nd, 1843 in her 82nd year of age. This bible came to their son Samuel White whose daughter Annie gave it to Ada R. MacMillan (grand daughter of William White) and the latter presented it to me, on June 8th 1924, in Lancaster Pa. on the 78th anniversary of the death of the above John White who died June 8th 1846, in the 86th year of his age

8. What follows is an excerpt from the deed where John White bought the Orange Street, Lancaster, Pennsylvania property from Edward Leeds Jun'r. I was unable to get a good copy of the original document from the Lancaster County Deed book K 6 167 & 8.

Lancaster in Book R., Vol. 6 page 167 & 8, reference thereunto being had, will appear Together with all and singular other the houses out houses, buildings, barns, stables, ways, woods, waters, water courses, rights, liberties, privileges hereditaments and appurtenances whatsoever, thereunto belonging, or in any wise appertaining, and the reversions and remainders, rents, issues and profits thereof And also all the estate right, title interest property, claims and demands whatsoever of them the said John White and Catharine his wife, in law or equity, or otherwise howsoever often to or out of the same. To Have and to hold the said one story brick dwelling house and half lot of Ground here hereditaments and premises, hereby granted or mentioned or intended so to be with the appurtenances, unto the said Josehp White his heirs and assigns to the only proper use and behalf of the said Joseph White his heirs and assigns forever. And the said John White for himself, his heirs, executors, and administrators, doth covenant promise grant & agree to and with the said Joseph White his heirs and assigns, by these presents that he, the said John White and his heirs the said hereditaments and promises, hereby granted or mentioned or intended so to be with the other person and persons term or any of them shall and will warrant and forever defend by these presently. Observation: John and his family were devout Presbyterians. Their last address was on West Orange Street in Lancaster. The only Presbyterian Church in Lancaster still exists on East Orange Street and was called the English Presbyterian Church early on. I have found no record of their burial in any cemetery in or near Lancaster County. I suspect that John, Catharine, and Isabella, the eldest daughter, are all buried in the English Presbyterian Cemetery, next to the church, at the time of their deaths in 1846, 1843 and 1840 respectively. Other family members are known or suspected to be buried there. Unfortunately, for research purposes, the cemetery was covered over in 1889 by the Evans Chapel and an education building behind it. Two known attempts were undertaken to identify all the people buried there but many were buried under many feet of dirt as part of the support for the buildings above and never identified. There are 279 names and an additional 82 more initials on a plaque on a wall in the "cemetery room" under the chapel and next to a wall near the original cemetery. This list includes John Hervey White, son of Samuel and Hanna A. White and three others.

Notes for CATHARINE SPROUL:

Note in the original John White's Bible that Catharine White departed this life July 2nd 1843 in the Eighty second year of her age.

Note: I have seen her maiden name spelled "Sproul and Sprowl" throughout my research from different resources. In the John White Family Bible it is "Sprowl". Her grandson's middle name is Sproul and there is a road crossing Bell Road, where the White Family farms were, called Sproul Road also.

3. W. Whiteside 18th copied (1833)

"John White jun decd, on the petition of Abraham McConnel, Administrator of the estate of John White jnr deceased, respectfully begs leave to state: That he settled his account on the estate of the said deceased on the 19th day of September, 1831 on which there was a balance due the estate of \$60.04. The deceased left a widow and three children all of who are Minors, to wit Samuel P., Mary E., and Catharine J. who have no guardian to take care of their persons or estate. Samuel Johnson was appointed their guardian by your Honor but he has since died without ever having received any part of the said Minors estate in his hands. Your petition therefore respectfully prays, Your Honor to appoint their Mother Tirsah guardian over their persons and estates, and she will pray Petition read Whereupon the Court appoint Tirsah White the Mother of said minors guardian over their persons and estates, ongoing security approved of by the Court."

By force and virtue of said recited Indenture the said John White became in his lifetime lawfully seized in his demesne as of fee of and in the hereinafter described premises with the appurtenances and being so thereof seized died intestate; after whose death to wit at an Orphans Court held at Lancaster in and for the County of Lancaster the sixteenth day of January Anno Domini 1832 upon the petition of Tierzah White the widow and relict of the said John White decd and guardian duly appointed over the persons and estates of the minor children of the said deceased stating to the said Court that the personal estate of the said deceased was not sufficient for the education and maintenance of the minor children of the said intestate and praying the Court to direct a Sale to be made of the above mentioned Premises; it was considered and ordered by the said Court that the premises aforesaid should be sold at Public Sale on the eighth day of February Anno Domini 1832 and continued to the sixth day of February Anno Domini 1833 for the purpose aforesaid and that a report of the proceedings thereof be made to the next Orphans Court to be held for said County after such Sale. In Pursuance of said Order the said Abraham McConnel Administrator aforesaid to sale by Public Vendue or Outcry and sold the same to John Townsend for the sum of Four Hundred and Eighty two Dollars and seven Cents lawful money of the United States he being the highest bidder and that the best price bidden for the same which sale on report thereof made to the Judges of the said court was on the 21st day of March following by them confirmed. And it was considered and adjudged by the said Court that the

same should be and remain firm and stable forever as by the records and proceedings of the said Court relation being thereto had will at large appear

"William R. White came to Ashland County, Ohio in 1864 and purchased a farm of 200 acres in Milton Township, living there until his death. In spite of many reverses in the way of fires, etc. he won a gratifying measure of prosperity in his business undertakings. He did not hoard his capital, however but used it freely in providing his children with food, educational advantages and opportunities and also in aiding the poor. He was a member of the Presbyterian Church which he faithfully attended and served as an elder of for more than 40 years. Though the church was three miles from his home and the weather was often inclement, he never failed to be in his accustomed place at religious service. His life may well serve as an example for others to follow being characterized by integrity, purity, and uprightness in all relations. The community mourned the loss of one of the most respected and honored citizens when he passed. William was a native of Lancaster County, Pennsylvania and his wife was a native of Westmoreland County, Pennsylvania."

Elder William R. White

William R. White, one of the patriarchal citizens of Milton Township died rather unexpectedly last Friday morning at 5:30 o'clock. Though he had been in feeble condition for some time, he arose as usual that morning. He complained of being chilly, and while his wife built a fire he lay down on a lounge. Mrs. White went outside the house for a few minutes, and when she returned, she found him dead.

Mr. White was a Pennsylvanian by birth having been born in Lancaster County 75 years ago. He came to this county in 1867 and purchased the farm he occupied to his death. He was married twice, his second wife surviving him. Seven sons and two daughters survive him, vis: Mrs. Agnes Craig, of Lancaster County, Ohio, and Mrs. Addie Gillis of Hayesville. Park and Sidney, of Indiana; John, Fred, and Walter of Pittsburgh, Alvin of Ashland and Reverend S.E.P. of Minnesota. All of the sons are physicians or dentists but Walter and S.E.P. For 20 years the deceased was an elder in the Presbyterian Church here and in his belief he was a churchman of the strictest sort.

The funeral services were held Sunday afternoon in the Presbyterian church conducted by the pastor, Rev. D.B. Duncan. Two of Mr. White's brothers from Westmorland County Pennsylvania were present.

"Mrs. William R. White, who died last Friday at the home of her son, Dr. John R. White, in Warsaw Indiana; of acute tonsillitis was brought her for burial on train 16 Sunday afternoon. Ever since the death of her husband, Elder Wm R. White, she has spent the greater part of her time with her daughter, Mrs. Gillis, and her sons in Indiana. Eva Paul was born March 6,1840 in the state of Pennsylvania; united in marriage to Wm. R. White Jan 5, 1859. Left Pennsylvania and came to Ohio on 1865 and purchased a farm 3 miles south west of Ashland where they resided until death separated them. Then White and his wife Treva, were equal partners until she died in 1967. Since that time, White has been the sole proprietor of White Funeral Home, 221 W. Lexington Ave. White learned the trade from his uncle, and he and his wife were licensed undertakers. There were four other funeral homes in Elkhart 50 years ago, just like today, White said. One of the differences between the business now and in 1928 is that embalming used to be done in the home, White said. that was before a state law required it to be done in the funeral home, he said. Services were almost always held in the family's home 50 years ago, he said. All of Elkhart's funeral homes used to run ambulances services, White said, but he sold his equipment to an ambulance company about 14 years ago, he said. White said he never thought too seriously about quitting the business once he began, because "when a young person person invested that much money in it he just stuck with it." The cost of beginning a funeral home today is much higher, White said, and most young people who begin in the business are relatives of someone who already operates one. White said the hours were longer 50 years ago than today, because of advancements in the field, but he said he needs to keep working. "I never really had the time for any hobbies," he said, so working is his chosen way of keeping busy."

White on U.S. route 30 just east of Warsaw, monday at 9 p.m. His death came as a result of several strokes from which he suffered recently.

He was pastor of the Presbyterian church at Onalaska, Wash., and was compelled to give up his work recently on account of his health. He was given a year's leave of absence by his congregation and came east expecting to spend the winter with relatives in Toronto, Canada. He and his wife left Seattle on October 6, stopping in Warsaw to visit his brother, Dr. John R. White and family en route. They arrived here October 9 and expected to leave for Toronto on Sunday October 31, but on Wednesday, October 27, he was the victim of a second stroke which made it impossible for him to be moved. He grew gradually weaker until Monday evening when death overtook him.

Rev. Samuel E. P. White was born in Ashland, O., January 1, 1870. He was a graduate of Wooster College in 1896. He studied one year at Princeton Theological Seminary and graduated from McCormick Theological Seminary in Chicago in 1899. He was pastor for ten years of the Presbyterian church at Bemidji, Minn., five years pastor at Longmont, Colo. He gave ten years of his life to the work of a Christian Ministry in the Presbytery of Seattle and for a number of years served as pastor of the Presbyterian church at Onalaska, Wash. During the years of his work among the lumbermen of the north-west he endeared himself to them and to the hearts of the christian people of the entire state. His brethren honored him by electing him moderator of the Synod of Washington, which is the highest honor they could confer upon him.

He is survived by his widow, Mrs. Ethel Roper White, and one son, John R. White of Seattle, also by two brothers, Dr. John R. White of Warsaw, and W.L. White of Mansfield, Ohio. Funeral services will be held at the Dr. J.R. White residence on route 30, East of Warsaw, Wednesday at 2:30 p.m. Dr. A. W. Rabee, pastor of the Presbyterian church officiating. The funeral will be in charge of Dale White, a nephew, of the White funeral home in Elkhart. The body will be taken to Fort Wayne for cremation."

Burial will be in Oakwood cemetery. Friends will be received at the Landis funeral home after 7 p.m. Saturday until 11 a.m. on Monday and at the church from noon until the time of the service.

RETIRES IN 1946

Dr. White retired form active practice and was succeeded by Dr. Eugene F. Yoder April 6, 1946. He began his practice in Warsaw in 1898 when he occupied an office directly opposite the location at which he has practiced for so many years. At the beginning he was associated with the late Dr. R. Parks White, his brother, a physician, who is well remembered in this community and who later transferred his practice to Fort Wayne. Dr. White continued his first location for ten years, when he moved into the Haymond building which was his location until his retirement.

Dr. White was soon recognized in this city as an able man in the dental profession. He developed a practice that included patients from other communities and from great distances, who came to take advantage of his skill. He was held in high regard throughout the community because of his humane interest and his kindness to those who were under-privileged and unfortunate."
